DISCLAIMER

1. This is to inform you that the claim amount submitted by you was verified by Resolution professional (RP) basis documents submitted by you and Company's records available with us.

Please that the Resolution Plan submitted by Resolution applicant was approved by COC on 27 January 2020 and the same was filed by Resolution Professional before the Hon'ble NCLT, Delhi on 05.02.2020 for its approval. Therefore, under the Insolvency and Bankruptcy code, 2016 RP has no power to admit further claims.
3. The amount paid by Financial Creditors includes service tax also (@ approx. 3%), which is already paid/payable to Tax authorities, Hence the principal debt verified excludes the amount collected as Service tax by the Company.
